#### J:1020:11 Report from Celia Price re the year-end accounts for 2020/2021

Following her meeting and discussion with the auditors for Upper Beeding Parish Council, Celia Price advised Councillors that, with effect from the year-ending 31 March 2021, surplus monies from Botolphs Cemetery would be divided, on paper only, between Bramber, Steyning and Upper Beeding Parish Councils.

The auditors require that this action be taken so that it would stop the inflation of Upper Beeding Parish Council accounts by the monies that it holds on behalf of the Joint Burial Authority of Bramber, Steyning and Upper Beeding Parishes Council.

It was noted that the Parish Clerks of Bramber and Steyning had already been advised of the matter and that monies would be divided as listed in the original titled deeds with the relevant sum being shown in the appropriate Parish Council end-of-year accounts:

Bramber Parish Council - two twentieths
 Steyning Parish Council - nine twentieths
 Upper Beeding Parish Council - nine twentieths.

Celia was thanked for her oral report.

#### J:1020:12 Interim reports for Botolphs Cemetery

The Cemetery Clerk provided Councillors with an interim written report for Botolphs Cemetery together with:

- a) a copy of the Cemetery plan to 25 October 2020
- b) data re interment of burials and cremated remains to 25 October 2020

It was noted that the left-hand side of the cemetery, nearest St Botolphs Church, had been re-measured and it was felt that nine further burial places could be accommodated.

In the discussion that ensued, and in preparation for the next meeting, the Cemetery Clerk was requested to provide Councillors with:

- a) draft guidelines for the installation and positioning of benches, similar to that already used for memorials
- b) a report detailing the costs of the new signage required at the Cemetery.

The Cemetery Clerk was also requested to arrange a site meeting at Botolphs Cemetery, in order that all Councillors could acquaint themselves with its layout and discuss any necessary matters.

The Chair thanked the Cemetery Clerk for her written report.
